Privacy Policy

(mandatory information according to Art. 13 and 14 EU-GDPR)

With this information we are informing you about how your personal data is processed and your rights under the data protection laws.

(1) Responsible for data processing

European Sport Economics Association (ESEA) e.V., Universitätsstraße. 30, 95447 Bayreuth, Germany, legally represented by its committee according to § 26 BGB (German Civil Code), e-mail: secretary@sporteconomics.eu.

(2) Data Protection Officer

Since less than 20 persons are regularly responsible for the handling and processing of personal data, no data protection officer has been designated according to Art. 37 Sub 1 lit. b and c GDPR in conjunction with § 38 BDSG-neu.

(3) Collection and use of personal data

Below you will find detailed information on how we use your personal data.

a. Administration of your membership

We use the following personal data to administer and manage your membership: name, affiliation, date of birth, e-mail address, PhD student status. We use your personal data for the fulfilment of contracts (Art. 6 Sub. 1 lit b GDPR). Your membership is the relevant contract. We process the personal data for this purpose for the duration of the membership and will delete them 2 years after your membership has ended. Between the end of your membership and the deletion, we are only processing the personal data to a limited extent. In addition, we store your personal data for the assertion of, or defense against, legal claims or as long as there are legal obligations on storage.

b. Answering your contact requests

We use the following personal data to answer your contact requests: name, e-mail address, content of your message. We process your personal data to fulfil the contract (Section 6 Sub. 1 lit. b GDPR). We only process the personal data for as long as we need to answer your request. In addition, we only store your personal data for the assertion of, or defense against, legal claims or as long as there are legal obligations on storage.

c. Administration of the access to the International Journal of Sport Finance

If you have attended the ESEA conference, you are entitled to electronic access to the International Journal of Sport Finance. In that case, we share the following personal data to administer the access to the International Journal of Sport Finance with the publisher of the journal (Sage Publications, Inc., 2455 Teller Road, Thousand Oaks, California 91320, United States of America): name, e-mail address. We process the personal data for this purpose for the duration of the membership. In addition, we only store your personal data for the assertion of, or defense against, legal claims or as long as there are legal obligations on storage.

d. Images of public events

We produce photographic and video recordings of public association events (in particular photos from the ESEA conference incl. the PhD workshop) that show our members and we publish these on our webpage (www.sporteconomics.eu) to inform and report on public

association events. We process your personal data for this purpose based on our legitimate interest on reporting the activities of our association (Section 6 Sub. 1 lit. f GDPR). We process the personal data to fulfil this purpose. In addition, we only store your personal data for the assertion of, or defense against, legal claims or as long as there are legal obligations on storage.

e. Images from other events

We produce photographic and video recordings of other association events (in particular photos from social events like the conference dinner) that show our members and we publish these on our webpage (www.sporteconomics.eu) to inform and report on these particular activities. We produce these photographic and video recordings of other sporting activities based on our legitimate interest of reporting on the activities of our association (Section 6 Sub. 1 lit. f GDPR). These images will only be published with your consent (Section 6 Sub. 1 lit. a GDPR). You may withdraw your consent at any time. Publication of images based on consent before withdrawal remain legitimate. However, consent with multi-person images is irrevocable unless the weighting of interests is not in your favor. We process your personal data until withdrawal of your consent and otherwise up to the completion of the purpose pursued. In addition, we only store your personal data for the assertion of, or defense against, legal claims or as long as there are legal obligations on storage.

f. Images from keynote speeches

We produce photographic and video recordings of keynote speeches that show our members, and we publish these on our website (www.sporteconomics.eu) and on YouTube (www.youtube.com) to inform and report on these particular activities. We produce these photographic and video recordings of keynote speeches based on our legitimate interest of reporting on the activities of our association (Section 6 Sub. 1 lit. f GDPR). These images and recordings will only be published with your consent (Section 6 Sub. 1 lit. a GDPR). You may withdraw your consent at any time. Publication of images and recordings based on consent before withdrawal remain legitimate. However, consent with multi-person images is irrevocable unless the weighting of interests is not in your favor. We process your personal data until withdrawal of your consent and otherwise up to the completion of the purpose pursued. In addition, we only store your personal data for the assertion of, or defense against, legal claims or as long as there are legal obligations on storage.

g. Images of board members and award winners

We use the following personal data to inform about our board members and award winners, and we publish these on our website (www.sporteconomics.eu): name, e-mail, board position, photo, short CV. These personal data will only be published with your consent (Section 6 Sub. 1 lit. a GDPR). You may withdraw your consent at any time. We process your personal data until withdrawal of your consent and otherwise up to the completion of the purpose pursued. In addition, we only store your personal data for the assertion of, or defense against, legal claims or as long as there are legal obligations on storage.

h. Chronicles

We use the following personal data to produce and publish chronicles of the association: name, date of joining the association, date of leaving the association, presentations at ESEA conferences (date, title, co-authors), board positions held. We produce and publish chronicles based on our legitimate interest of the historical documentation of the activities of the association (Section 6 Sub. 1 lit. f GDPR).

(4) Data Storage

Only personal data which are necessary for each specific purpose of the processing are processed (Section 25 Sub. 2 lit. f GDPR). All data will be deleted as soon as they are no longer required for the fulfillment of the purpose of their collection. We store membership data using a cloud-based solution. Data is encrypted before being uploaded and can only be decrypted using a password. Access to the membership data and the decryption password is held by the general secretary and the president of the association.

(5) Your Rights

Providing the requirements in the respective regulations are met, each member of the association has the following rights:

- the right of access according to Art. 15 GDPR,
 - the right to rectification according to Art. 16 GDPR,
 - the right to erasure ('right to be forgotten') according to Art. 17 GDPR,
 - the right to restriction of processing according to Art. 18 GDPR,
 - the right to data portability according to Art. 20 GDPR,
 - the right to object according to Art. 21 GDPR,
 - the right to complain to a data protection authority according to Art. 77 GDPR,
 - the right to revoke a given consent to processing your personal data at any time.
- Data processed before withdrawal is still valid.

(6) Changes

Our privacy policy may change from time to time. Any updates to the privacy policy will be published on our webpage and sent to our members via e-mail.
